# Empowerment of Midwives in Increasing Knowledge as a Result of Malpractic Incidents Reviewed from the Legal Aspects in the Working Area of the Puskesmas Kerek Kabupaten Tuban

A child's future is largely determined by his health in the womb and at an early age. It is important to pay attention to the health of pregnant women, considering that there are still many complications during pregnancy and childbirth that have an impact on the child's health. The midwife's responsibility if the service provided to the patient turns out to be detrimental to the patient is absolute responsibility (Abate et al., n.d.). Midwives are responsible for all actions and decisions taken in providing midwifery services. Midwives are also responsible for the mistakes of other midwives who carry out their profession. The legal remedy that a patient can take if harm is caused by the midwife's actions in midwifery services is to file a civil lawsuit based on the midwife's unlawful actions which caused harm to the patient. Midwives who make mistakes, are negligent and are careless are actions that are detrimental to patients (KEMENKES RI, 2019). Midwife professional standards, qualification standards, treatment standards and ethical rules are the basis of a midwife's midwifery work (Rona, 2020). The problem is that there are incidents of malpractice in Kerek sub-district carried out by midwives on women giving birth which causes harm to the patient, namely the baby dies, so the health sciences faculty collaborates with the IBI Kerek sub-district branch and the Kerek Community Health Center to provide guidance and counseling to all village midwives in Kerek sub-district to improve quality of service to patients with the aim of reducing maternal and infant morbidity and mortality in Kerek Sub district.

### **METHODS**

Based on the problems described previously, we intend to hold a socialization activity regarding the SOP for midwives in accordance with the 2017 RI MENKES PERMENKES. This activity involves the participation of lecturers and students from the health sciences faculty and the law faculty at Dr. Soetomo University, Surabaya.

This activity is carried out by providing counseling and training on midwife SOPs in accordance with the 2017 RI MENKES PERMENKES and providing demonstrations on health services in accordance with the SOP. This activity aims to ensure that midwives at the Kerek Tuban Community Health Center are more careful in providing services to the community, especially in providing maternal and child health services. This activity will be carried out pre-test and post-test to determine this success.

From the pre-test calculation results, there were 23.6% of midwives with sufficient knowledge, 17.6% with poor knowledge and 58.8% good knowledge, whereas after being given counseling and carrying out a post-test, the post-test results were found to be 100%.

## **DISCUSSION**

From the results of the pre-test, it was found that the knowledge of midwives at the Kerek puskesmas was still lacking, so it was necessary to conduct guidance on SOPs in accordance with the Indonesian Ministry of Health, so that we, the Faculty of Health Sciences, and the Faculty of Law collaborated to provide counseling and training to midwives to increase midwives' knowledge about SOPs in accordance with the Indonesian Ministry of Health (Alender, et al., n.d.). This is because Midwives are responsible for all actions done and decisions made in providing midwifery services. Midwives are also responsible for mistakes made by other midwives working in their practice. Legal remedies that can be taken by patients if there is a loss as a result of actions carried out by midwives in providing midwifery services are by filing a civil lawsuit based on unlawful acts committed by midwives Thus resulting in losses to patients so that it is necessary to conduct coaching to midwives. After counseling and training, a post test was carried out again for the midwives and 100% results were obtained (KEMENKES RI, 2019).

## **CONCLUSION**

The community empowerment program for midwives at the Kerek Health Center about malpractice through the provision of counseling and training on midwifery SOPs, this can increase knowledge and reduce the risk of malpractice incidents at the Kerek Health Center.
